Appointed CleanCo Queensland's Chief Executive Officer in July 2022, Tom Metcalfe is at the helm of Queensland's publicly-owned low-emission and renewable energy generator, retailer and developer. He has more than 30 years' experience in the global energy sector and is using this experience to guide CleanCo to achieve its ambitious goals and support decarbonisation across Queensland.

As CEO of CleanCo, Tom oversees more than 1,100MW of low-emission generation assets including Queensland's only pumped hydro, with the portfolio set to grow exponentially over the next decade to help propel Queensland's energy transformation forward.

In his previous role as President of both We Energies and Wisconsin Public Service in the United States, Tom oversaw the delivery of gas and electricity to approximately 3 million customers. Tom has successfully delivered more than 5000MW of new generation in the United Kingdom, Asia, Australia and the United States.

For CleanCo, the stage is set for a big year in 2024. The government-owned energy company is at the forefront of Queensland's energy transformation, tasked with building the energy portfolio of the future.

Tom will discuss the organisation's ambitious growth agenda which includes spurring the development of 5GW of renewables by 2030 through a combination of owned assets and long-term offtake agreements. Highlighting key market insights, Tom will also share his thoughts behind current price signals, customer trends and the infrastructure needed for a successful energy transition. He will explore the ways in which CleanCo is working with industry partners and communities in a responsible and sustainable way, and explain how the portfolio the company is building, will support Queensland's biggest energy users to decarbonise and thrive in a net zero future.

Tom has a Bachelor of Engineering, Power and Energy from the De Montfort University, Leicester, UK.
